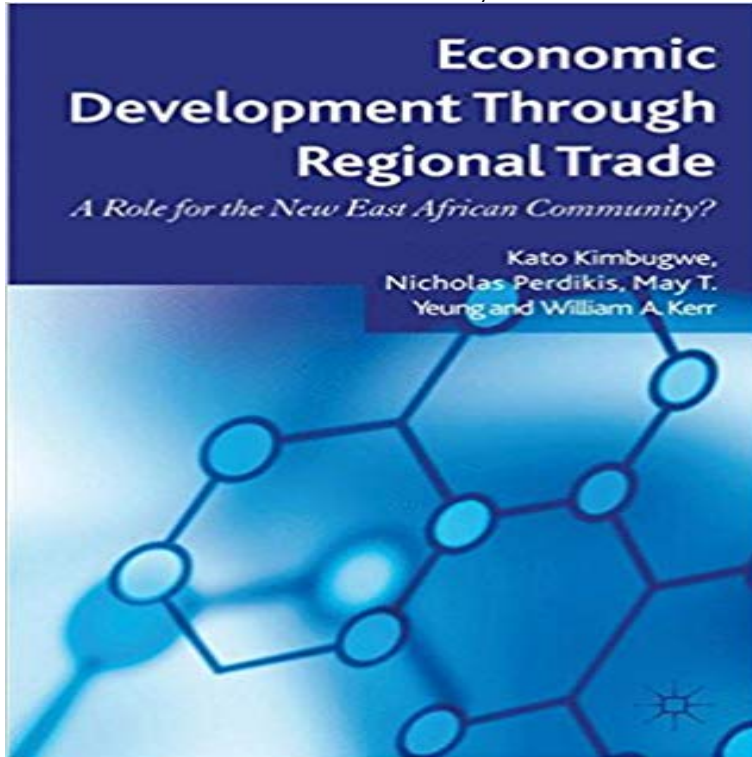


Economic Development Through Regional Trade: A Role for the New East African Community?
